JUDGMENT

JUDGMENT IS ENTERED AS FOLLOWS:

On Claim 1 of Plaintiffs' complaint, the Court declares that the restrictions on abortion in Idaho Code § 18-622 and Idaho Code §§ 18-8801 to -8805 do not prohibit performing an "abortion" as defined in Idaho Code § 18-604(1) if, in the performing physician's good faith medical judgment (based on the facts known to the physician at the time of the abortion), the patient—because of an existing medical condition or pregnancy complication that would be alleviated by an abortion—faces a non-negligible risk of dying sooner without an abortion (even if

her death is neither imminent nor assured), so long as (i) the risk of her death doesn't arise from a risk of self-harm, and (ii) the manner of pregnancy termination is the one that, without risk increasing the risk of her death, best facilitates the unborn child's survival outside the uterus, if feasible.

Plaintiffs' other claims are dismissed with prejudice.
