And, rather than adding new legal arguments not already covered by the parties, the proposed brief makes irrelevant references to Franz Kafka, George Orwell and dystopian speculations in an attempt to distract the court from the true legal claims. Such arguments do not comply with NMRA Rule 12-320 and should therefore not be accepted for consideration by this Court.
