Amicus curiae the County Prosecutors Association of New Jersey (CPANJ) is in receipt of plaintiff-appellant's Petition for Certification in the above-captioned matter. CPANJ opposes the Petition and relies upon its brief below, defendant-respondents' brief, and the unpublished opinion of the Appellate Division affirming the Law Division's dismissal of plaintiff-appellant's complaint and its denial of plaintiff-appellant's request injunctive relief.

We urge that the Petition be denied since, as far as CPANJ can tell, it does not present a question of general public importance that has not

but should be settled by the Supreme Court; nor is it similar to a question presented under another appeal; nor is it in conflict with any other decision of the same or higher court; nor does it call for an exercise of the Supreme Court's supervision.
