Having considered the pleadings, evidence, memoranda, law, and oral arguments on the foregoing Application for Preliminary Injunction and the Motion *in Limine*,


**IT IS ORDERED** that the Application for Preliminary Injunction filed by Plaintiffs is hereby **GRANTED**, and that Defendants Jeff Landry, the Attorney General of Louisiana, and Courtney N. Phillips, the Secretary of the Louisiana Department of Health, and all of their officers, agents, and assigns are hereby **ENJOINED** from enforcing or implementing La. R.S. §§ 14.87.7, 14.87.8, and 40:1061 until such time that a trial on Plaintiffs' request for a permanent injunction be had.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Defendants' Motion in *Limine* to Exclude Evidence at the Hearing on Preliminary Injunction is hereby **DENIED**.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the parties shall confer via email with Section 24 Staff Counsel no later than 30 days from the date of this judgment to develop a case management schedule for the trial on the merits of a permanent injunction.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the return date by which any party may file an application for a supervisory writ is August 12, 2022 regarding the judgment rendered herein above. Written findings of fact and conclusions of law are forthcoming.
