#### I. ARGUMENT

Pursuant to Rule 2185 of the Pennsylvania Rules of Appellate Procedure.

Except as otherwise provided by this rule, the appellant shall serve and file appellant's brief not later than the date fixed pursuant to Subdivision (b) of this rule, or within 40 days after the date on which the record is filed, if no other date is so fixed. The appellee shall serve and file appellee's brief within 30 days after service of appellant's brief and reproduced record if proceeding under Rule 2154(a) (general rule).

Pa. R.A.P. 2185. In the instant matter, upon the granting of defendants' Petition for Allowance of Appeal, the Court set a briefing schedule. See Appendix A. Pursuant to this briefing scheduling, defendants' brief and reproduced record was due on December 5, 2022, and plaintiffs' brief was due thirty (30) days thereafter.

On November 15, 2022, defendants filed their first and only Application for Extension of Time to File Brief, wherein defendants requested a thirty (30) day extension of the December 5, 2022 deadline in order to allow the ACLU of Pennsylvania time to file an *amicus* brief. Plaintiffs' counsel did not respond to defendants' request, nor to the Court's numerous requests for plaintiffs' position. Therefore, a decision on defendants' application was delayed until December 1st. The application was granted and the deadline

for defendants' brief was moved to January 5, 2023. Defendants filed their brief on January 4, 2023.

Plaintiffs' brief was initially due on February 6, 2023. However, on February 3, 2023, plaintiffs filed their First Application for Extension of Time to File Brief and Supplemental Record. Defendants' counsel advised this Court that defendants would not be filing a response to the application. The application was granted on February 6, 2023 and the deadline for plaintiffs' brief was moved to February 24, 2023. See Appendix B.

A second application was filed on February 24, 2023, seeking to extend plaintiffs' deadline to March 10, 2023, to which defendants objected. The Court ultimately granted the application, but *only to the extent* that plaintiffs' brief was due on March 3, 2023. See Appendix C.

Nonetheless, on March 3, 2023, plaintiffs filed a Third Application for Extension of Time to File Brief and Supplemental Record, requesting that the Court extend the deadline once again to March 6, 2023. Again, defendants objected to this request. The Court the denied the Application and entered the following Order:

**AND NOW**, this 3<sup>rd</sup> day of March, 2023, Appellees' third application for extension of time is **denied**. Appellees' Brief remains due by March 3, 2023, and can be PACFiled by 11:59:59 p.m.

See Appendix D.

Plaintiffs did not file their brief by March 3, 2023 as required by the Court. Instead, plaintiffs filed their brief on March 6, 2023 at 5:59 p.m. The Office of the Prothonotary for the Supreme Court of Pennsylvania confirmed the untimely receipt of plaintiffs' brief by way of letter dated March 7, 2023. See Appendix E. Plaintiffs' failure to file a timely brief is particularly egregious given that Rule 2139¹ allows appellees to simply refile their brief filed with the Superior Court. Pa. R.A.P. 2139.

Pursuant to Rule 2188,

If an appellant fails to file his designation of reproduced record, brief or any required reproduced record within the time prescribed by these rules, or within the time as extended, an appellee may move for dismissal of the matter. If an appellee fails to file his brief within the time prescribed by these rules, or within the time as extended, he will not be heard at oral argument except by permission of the court.

On appeals from the Superior Court or the Commonwealth Court, appellants may prepare new briefs in the Supreme Court according to these rules, setting forth also the order allowing the appeal, or may utilize the briefs, if available, used in the appellate court below (changing the cover, however), and adding thereto the order allowing the appeal, the opinion and dissenting opinions, if any, of the appellate court below (if reported, stating where) and such additional argument as may be desired. Appellee may also prepare a new brief or *may utilize the one used in the appellate court below*, if available, with such additional argument as may be desired.

Pa. R.A.P. 2139 (emphasis added).

Pa. R.A.P. 2188. Given plaintiffs' significant non-compliance with the Court's March 3, 2023 Order, defendants ask that this Court deny any request by plaintiffs to participate in oral argument.
