In response to Justice Gordon-McCloud's question whether a takings plaintiff can seek declaratory relief (Oral Arg. at 5:41-6:20, 7:40-7:52 (Feb. 23, 2023)), Appellants file this Statement of Additional Authorities pursuant to RAP 10.8.

The United States Supreme Court has allowed declaratory relief claims as to whether a taking would or did occur. See Duke Power Co. v. Carolina Env. Study Group, 438 U.S. 59, 71 & n.15 (1978); Ruckleshaus v. Monsanto, 467 U.S. 986, 998-99, 1013 (1984); E. Enterprises v. Apfel, 524 U.S. 498, 521-22 (1998); Knick v. Twp. of Scott, Pennsylvania, 139 S. Ct. 2162, 2168 (2019).

The Court has also allowed declaratory relief claims where the complaint alleges a *per se* physical taking. *See Cedar Point Nursery v. Hassid*, 141 S. Ct. 2063, 2070, 2080 (2021) (declaring that the challenged regulation effected a *per se* taking); *Pakdel v. City & Cnty.*

of San Francisco, California, 141 S. Ct. 2226, 2228 (2021) (claim without seeking compensation was justiciable; remand for resolution on the merits); see Pakdel v. City & Cnty. of San Francisco, 2017 WL 6403074, at *3 (N.D. Cal. Nov. 20, 2017) (noting that the complaint sought only declaratory relief).

This Court also has recognized that parties can seek a determination as to whether a government action has caused a taking. See Manufactured Housing Communities of Washington v. State, 142 Wn.2d 347, 351 (2000), abrogated on other grounds in Yim v. City of Seattle, 451 P.3d 675, 659 (2019); Ackerley Communications, Inc. v. City of Seattle, 92 Wn.2d 905 (1979) ("where no administrative remedy is available, ..., a party may be allowed to raise constitutional issues in a declaratory judgment proceeding").

Additionally, RCW 7.24.080 expressly allows parties bringing a declaratory relief to seek further relief "based on

a declaratory judgment." *Id.* And, the declaratory judgment statute is to be liberally construed. *DiNino v. State*, 102 Wn.2d 327, 330 (1984).
