Pursuant to RAP 10.8, the State of Washington respectfully provides the following additional authority, argument, and citation to briefing:

Haw. Rev. Stat. § 706-606.5 (recidivist sentencing statute imposing mandatory minimums, with no age restriction on predicate offenses). This authority relates to page three of the Appendix to the State's Supplemental Brief. The State's Appendix mistakenly listed Hawaii as a state whose recidivist sentencing scheme imposes mandatory LWOP in some circumstances—it is not. However, Haw. Rev. Stat. § 706-606.5, which was mistakenly omitted from the appendix, imposes mandatory minimums on certain recidivist offenders and does not impose any age restriction on predicate offenses.
